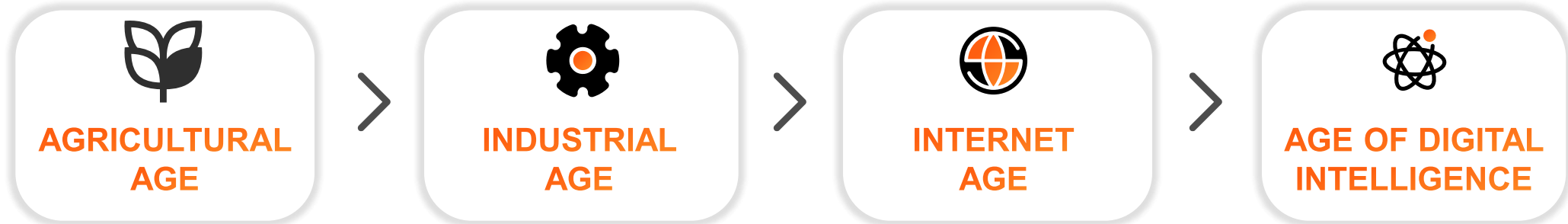

# DIGITAL INTELLIGENT ECONOMY - THE WEB3 ERA OF AI+RWA



The U.S. Stargate \$500 billion plan vigorously builds AI computing power infrastructure; The Chinese government, in its 2024 Government Work Report, explicitly outlined plans to formulate policies supporting the high-quality development of the digital economy. It will actively promote digital industrialization and industrial digitalization, and foster the deep integration of digital technology with the real economy. Simultaneously, the report calls for deepening the R&D and application of big data, artificial intelligence, and other technologies, launching an "AI Plus" initiative, and building internationally competitive digital industrial clusters.

## GENERABILITY

AGI (Artificial General Intelligence): Refers to a form of AI that can learn, reason, and solve problems across diverse domains, while also being able to navigate the social interactions of daily life. Distinction from ANI: Unlike ANI (e.g., voice assistants), which can only perform a predefined set of tasks, AGI exhibits intelligence that spans multiple domains and possesses the capacity for autonomous learning and adaptation.

## POTENTIAL SELF-EVOLUTION

Through continuous learning and self-improvement, AGI could gradually approach or even surpass human intelligence, thereby laying the groundwork for the emergence of Artificial Superintelligence (ASI).

## HUMAN-LIKE COGNITION

AGI not only mimics human behavior but also comprehends context, performs common-sense reasoning, and tackles novel, unseen problems. For instance, OpenAI's GPT series has demonstrated near-human reasoning capabilities in mathematical competitions like the International Mathematical Olympiad (IMO).

## Initial LP Setup

**10 million AIREV** tokens were allocated for initial LP deployment to ensure liquidity. The LP relinquished minting rights, and upon activation of the Simon Singularity, ownership will be transferred to the DAO fund.

## Cast using the stake pool quota

200 million AIREV tokens were minted through LP and AI Treasury Fund allocations to secure stake in the mining pool, with a fair distribution across the network.

**Total AIREV Supply: 210 million, with final circulating supply deflating toward approximately 21 million**

Economic System Balance: Dynamic deflation coefficient adjustment formula: When AIREV quantity  $\geq 21,000,000$

LP pool deflation rate: 2% daily-2% of LP pool circulation volume enters black hole address daily for destruction, gradually reducing final circulation to 21 million coins.

Simon's Singularity: When AIREV/BTCB liquidity pool reaches \$500, the singularity activates, transitioning mining pool quotas from gold standard to coin standard, initiating PancakeSwap secondary market trading.

# AI REVOLUTION DAO LP MINTING AUTHORITY RULES



## How to Add LP to Obtain Minting Rights?

AIREV obtains minting rights by adding LP. By sending USDT to the AIREV contract address on the BSC chain, the contract will automatically add AIREV/BTCB to the liquidity pool, granting LP minting rights and providing AIREV mining allocation.



### Detailed LP Minting Rules

**Underlying Public Chain:** BSC Chain

**Minimum Investment:** 10USDT

**LP Liquidity Pool:** AIREV/BTCB

**Minting Quota:** Investment Amount Sent to Contract Address  $\times$  N (Multiplier)

**Minting Method:** POS Staking Mechanism

**Daily Minting Volume:** Minting Quota  $\times$  1%  $\times$  DEI Index / AIREV Price of the Previous Day

N: Minting allocation multiplier,  $1 \leq N$ ; N is related to the DEI

**DEI Index:** The dynamic DEI index model (VMSAP) calculates a "Supply-Demand Balance Index" weekly based on five indicators. The balance index ranges from 0.5 to 1.2 — the POS mining cycle for a single stake ranges from 66 to 200 days. DEI (Dynamic Emission Index) — for the detailed model, see the AI Revolution DAO White Paper.

# AI REVOLUTION DAO RULES FOR SELLING AIREV TO OBTAIN BITCOIN

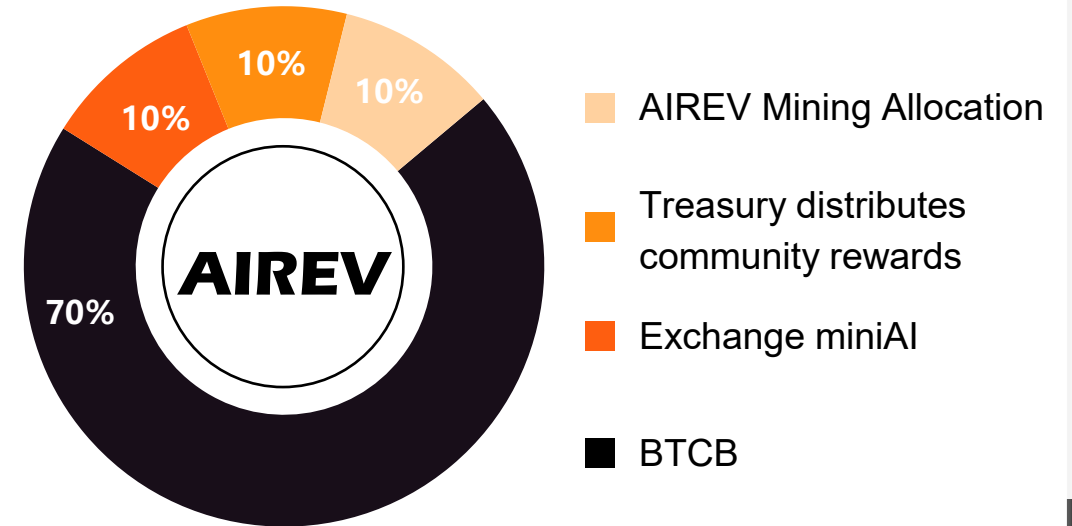

### Special Notes:

When AIREV reaches 21 million in circulation, it will no longer be destroyed. 10% of AIREV's value will be exchanged for miniAI. When the LP value of AIREV/BTCTB in Pancake SWAP reaches \$5 million and the Simon Singularity is triggered, Pancake SWAP on the secondary market will be activated. The equity mining pool will settle in coin terms, and AIREV will fully enter the value minting phase. The explanation is based on the DAO voting resolution.

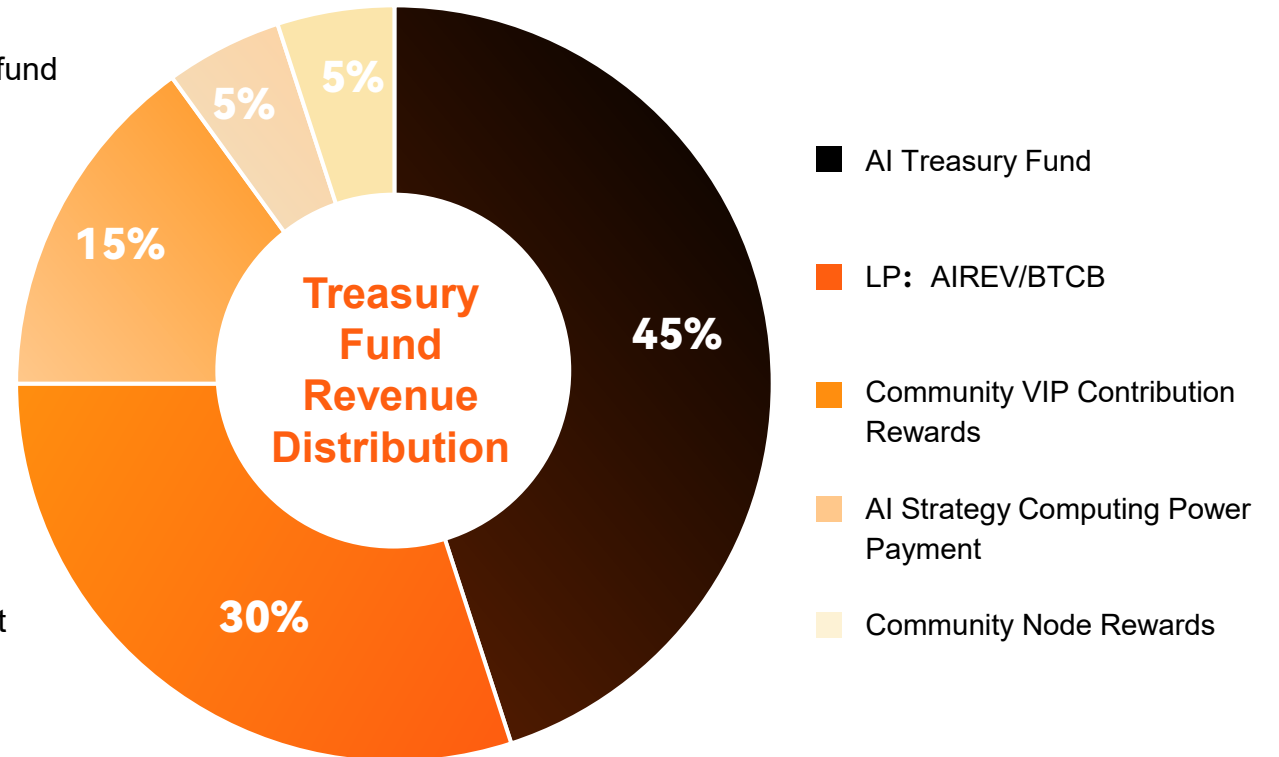

# AI REVOLUTION DAO COMMUNITY INCENTIVE PROGRAM



## Invite Users to Earn AIREV Rewards

Invite community members to deposit USDT to the AIREV contract address. When adding LPs to the AI Treasury Fund, they will receive an invitation reward from the mining pool. Additionally, invited users will earn a 10% transaction fee when depositing AIREV into the AIREV contract address.



## Invitation Reward Rules:

### 01 Direct Invitation:

- AIREV equivalent to **3%** of the USDT amount deposited by directly invited users
- 3%** of the amount of AIREV deposited by invited users into the AIREV contract address

### 02 Indirect Invitation:

- AIREV equivalent to **2%** of the USDT amount deposited by indirectly invited users.
- 2%** of the amount of AIREV deposited by indirectly invited users into the AIREV contract address.

For example: User A invites User B, and User B invites User C. If User C deposits 1,000 USDT into the AIREV contract address, then User B will receive AIREV equivalent to  $1,000 * 3\% = 30$  USDT, and User A will receive AIREV equivalent to  $1,000 * 2\% = 20$  USDT

# AI REVOLUTION DAO COMMUNITY INCENTIVE PROGRAM



## LIGHT Node Reward Pool

## SUPER Node Reward Pool

## NODE AIREV REWARD POOL

The network will allocate 5% of newly deposited USDT to AIREV tokens and 5% of AIREV deposits to the AIREV contract address as transaction fees to the node reward pool. Additionally, 5% of weekly profits from the AI Chain Treasury Fund will be allocated to the node reward pool.

### Node Pool Reward Distribution Rules

**Node Reward Calculation Rule:**  $\text{Node Weight Ratio} \times \text{Corresponding Node Pool Asset Amount}$

**Node Weight Ratio Calculation:**  $\text{Total USDT deposits added by single-node invitation chains in 30 generations} / \text{Total USDT deposits added by all qualified node invitation chains}$

**Node Pool Reward Distribution Rule:** For every 100 USDT deposits added to the network, AIREV contract settlement will be executed once, with the node reward pool distributing rewards to all qualified nodes.

# AI REVOLUTION DAO COMMUNITY INCENTIVE PROGRAM

## NODE PROMOTION RULES



### LIGHT NODE PROMOTION RULES

Condition:

The third-generation memory chain has reached a total USDT supply of 20,000, with the top 100 nodes in the ranking.



### SUPER NODE PROMOTION RULES

Condition:

The third-generation invitation chain has reached a total USDT deposit of 100,000, with the top 21 nodes meeting the standard.

TOP Ranking: Nodes meeting the criteria.

The invitation chain introduces a total USDT deposit contribution weight ranking.

For every 100 USDT deposits to the AIREV contract across the network, a node weight ratio is calculated. The top 100 LIGHT node weight ratios constitute the TOP ranking, while the top 21 SUPER node weight ratios form the TOP ranking. SUPER nodes do not receive LIGHT node rewards. Adjustments will be made according to DAO proposals.



## Community **VIP** Level-Up and Reward Rules

Community contribution levels are divided into V1–V9 based on performance assessments within the referral chain.

Members receive rewards from new USDT deposits into the AIREV contract and dividend rewards from the AI Treasury Fund.



### **Reward for Newly Deposited USDT into the AIREV Contract**

The reward is calculated based on the total new USDT deposits into the AIREV contract address by users in the referral chain, multiplied by the corresponding level reward coefficient. Equivalent AIREV rewards are then distributed from the mining pool.



### **AI Treasury Fund Dividend Reward**

Each VIP level's users share the corresponding AI Treasury Fund dividend pool equally. (Fund profits are distributed to the respective VIP dividend pools based on the profit base multiplied by the corresponding VIP pool coefficient. Rewards are settled weekly in USDT.)



# AI REVOLUTION DAO COMMUNITY INCENTIVE PROGRAM



## Community VIP Tier & Reward Rules

Community Contribution Levels V1–V9 Assessment Criteria: Remove the community with the highest total USDT deposits to the AIREV contract from the referral chain (i.e., the largest community). The total USDT deposits from users in all other referral chain communities to the AIREV contract are counted as performance for assessment (i.e., sub-community performance). For VIP1, the assessment requires 5 active users and a sub-community performance of 1,000 USDT.

## Ecosystem Symbiosis between miniAI Payment Token and AIREV

### miniAI Payment and Settlement Token

The miniAI payment token enables users to purchase AI products and services from the AI Revolution community, while earning 60% of AIREV mining rewards. This mechanism facilitates value circulation between consumption and data, fostering a symbiotic ecosystem.

### miniAI Swap

When users exchange USDT or AIREV for miniAI, 60% of the value is returned to the mining pool as equity, 30% is used to pay for computing power, and 10% of the AIREV value goes into the DAO treasury for community rewards.

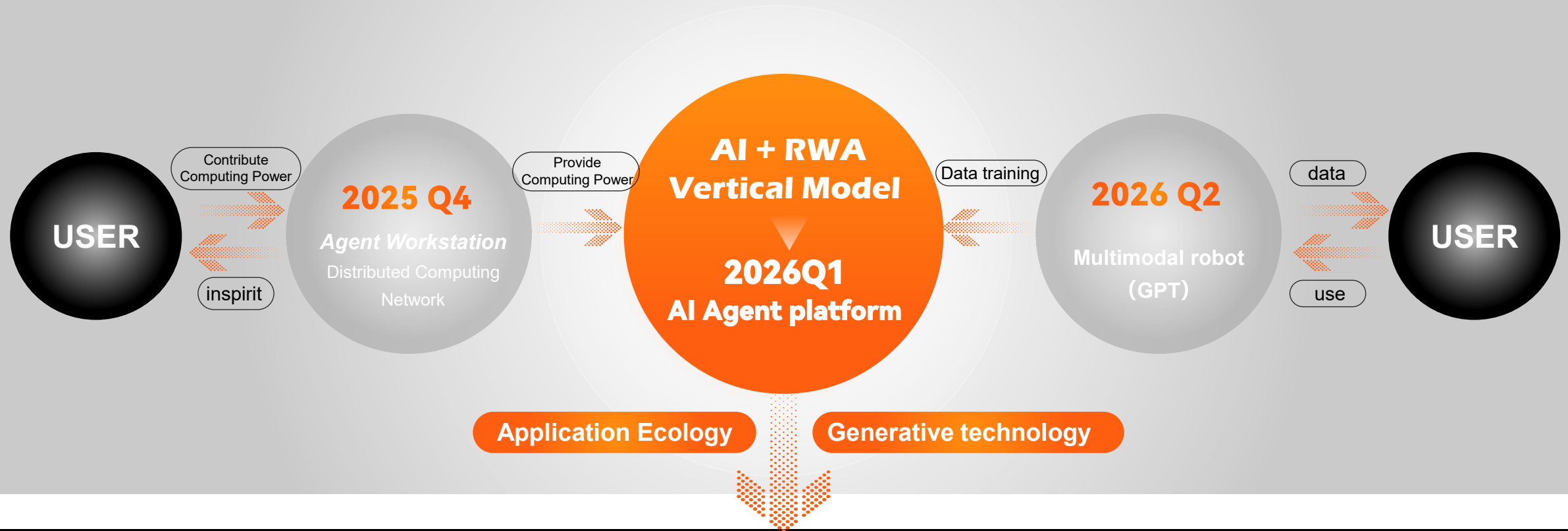
